Greetings to All My Relations!

Join us in person in June to engage in the community. This year's conference is themed "Radical self-care, Is an Act of Activism." There will be panel discussions and the unveiling of Unifor's racial justice work being presented at the Constitutional Convention. This year, the conference will occur after our first Racial Justice advocate training, many of which will stay for the conference and discuss our next steps one workplace at a time. Also, at this conference, we will celebrate Ruth Pryce, our long-standing National Executive Board member and Unifor local 1106 President is retiring. We will be hosting an election for the National Executive Board member. Anyone can run at the conference with support from their local. I ask any interested candidates to send a letter to the Human Rights Department expressing their interest in the position.

2022 is also an election year at our Convention for the top leadership positions of our Union. Black, Indigenous, and Workers of colour will have an opportunity to question the candidates that have put their names forward thus far. The candidates will be given time with the conference to answer questions from members in attendance.

The conference will provide a safe space for members who self-identify to share strategies skills and be in community with each other. The past years since 2019 at our last conference has been challenging for all of us and it is time to get back together to strategize, organize and build the union.

The conference is being held at the Unifor Family Education Centre in Port Elgin, Ontario. The conference will begin on Friday, June 17th at 6:00 pm and will adjourn on Sunday, June 19th, no later than noon. We must listen to each other, and the first step was the call for the change in the name in the constitution. The Regional committees met in March 2022 and unanimously endorsed the name change to Black, Indigenous, and Workers of colour. We have been actively working to advance racial justice and equality in our workplaces and communities. The Committees across the country have not stopped their activism, and we will have time to discuss our next steps.

On-Site Child Care Available
